This Cookies Policy explains what cookies are, how we use cookies on our websites, and what you can do to manage how cookies are used.

How we use cookies

Cookies are small files which are stored by internet browsers on your computer. They carry information about the browser that is passed to the webpage. Cookies are created or read when your page loads.

Confetti use cookies to:

- remember who you are when we need to show you content that you requested on a previous page of our website, or when you return to our website
- remember which notifications you've seen so that you see the correct messages
- collect information about how our website is used so that we can make improvements
- measure our marketing activities so that we can improve our communications.

The cookies we use will never identify you personally or contain any personal information.

Essential Cookies

These cookies are essential for our website to function correctly. Without them, you may not be able to do everything that you want to on our website, such as complete the open day booking form.

1. Google Analytics Universal

This is the most up to date way that Google collects data.

_utmc	Confettimedialogroup.com	Not used in ga.js. Set for interoperability with urchin.js. Historically, this cookie operated in conjunction with the _utmb cookie to determine whether the user was in a new session/visit	End of browser session
_utmt	Confettimedialogroup.com	Used to throttle request rate.	10 minutes
_utmv	Confettimedialogroup.com	Used to store visitor-level custom variable data. This cookie is created when a developer uses the _setCustomVar method with a visitor level custom variable. This cookie was also used for the deprecated _setVar method. The cookie is updated every time data is sent to Google Analytics.	2 years

_utmz	Confettimedialogroup.com	Stores the traffic source or campaign that explains how the user reached your site. The cookie is created when the javascript library executes and is updated every time data is sent to Google Analytics.	6 months
